Devereaux Dunlap Cannon, Jr., age 53 of the Rock Bridge community in Sumner County passed away Saturday, December 29, 2007. He is preceded in death by his mother Nancy Yancy Adair Cannon and brother Ty Cannon. He is survived by his wife Nora Tickle Cannon and daughter Nancy Katherine Cannon both of Rock Bridge, son 2 Lt Devereaux D. Cannon III and his wife Joleen of Ft. Bragg, N.C., his father Devereaux D. Cannon, Sr. and brother Cooper Cannon and wife Candy all of Ellendale, TN, two grandchildren, Devereaux D. Cannon IV and Brian Boru Cannon. Mass of Christian Burial was held at 9:30 a.m. Wednesday, January 2, 2008 at St. John Vianney Catholic Church, with Father John Sappenfield Celebrant. Burial was in Confederate Circle in Gallatin Cemetery.

Formerly commanding officer of the 201st Military Police Battalion, Lt. Col. Devereaux D. Cannon, Jr. was Staff Judge Advocate of the 2d Infantry Brigade, Tennessee State Guard. He was an active member of the Sons of Confederate Veterans, the Military Order of the Stars and Bars, and the Sons of the American Revolution. He was a Fourth Degree member of the Knights of Columbus, and was a member of the Board of Advisors of SOUTHERN PARTISAN magazine.

His books, all published by Pelican Publishing Company of Gretna, Louisiana, include: *The Flags of the Confederacy: An Illustrated History* (1988); *Flags of Tennessee* (1990); *The Flags of the Union: An Illustrated History* (1994); and *The Wit and Wisdom of Robert E. Lee* (1997). Devereaux D. Cannon, Jr. was a graduate of the University of Tennessee (BS, 1976)(JD, 1979) and was admitted to practice law in the Courts of the State of Tennessee. He was Assistant Vice President and State Counsel for Old Republic National Title Insurance Company in Nashville, Tennessee.

Compatriot Devereaux D. Cannon, Jr. served the Sumner Chapter of the Tennessee Society SAR as Secretary and Treasurer and was one of the most respected local historians in Tennessee. He will be fondly remembered by many as he is one whose chair may never be adequately filled.

MONUMENTAL ADVENTURES—DECEMBER 29, 2007

The Ninth Annual New Years
Tour hosted by SAR members
Cleo Hogan and Rick Hollis and

exploring diverse historical sites
in Montgomery, Robertson,
Cheatham and Dickson counties,

The driving tour was billed "Across the line to Cain-tuck!" and included the burial site of CSA General W. A. Quarles of Clarksville, passed the birthplace of VP Adali Stevenson and Jefferson Davis, toured the Kentucky home of US Senator John J. Crittenden and Florida Governor Richard Keith Call. toured historic Russellville, learned about the 2nd Great Awakening at Muddy River Meeting House (ignited religious revival in the early 1800s throughout America and toured Shaker Town at South Union with lunch at Shaker Tavern.

D. D. Cayce III/ Cleo G. Hogan A relative of CSA General W. A. Quarles, D. D. Cayce III met the group at the Quarles gravesite in Herndon, KY. Cayce bears a striking resemblance to his cousin, the famed clairvoyant Edgar Cayce, also of Hopkinsville.





The tour group of 22 enjoyed the hospitality of Crittenden Home owner Irene Algrim in Russellville, Kentucky. Refreshments were furnished by Vivian Stephenson, a friend of Ms. Algrim. Displayed prominently in the Crittenden-Algrim home was her late husband's NSSAR membership certificate verifying his direct descent from Daniel Boone.

John J. Crittenden was the son of Revolutionary War soldier John Crittenden of Virginia. In service as US Attorney General under Presidents W. H. Harrison, John Tyler and Millard Fillmore, he served in the US Senate during five separate periods and as a member of five separate political parties. He was Kentucky's 15th governor. Crittenden fought valiantly to save the Union from war and issued the famous Crittenden Compromise in 1860. His sons were USA Maj. Gen. Thomas L. Crittenden and CSA Maj. Gen. Geo. B. Crittenden.

and the Lebanon Democrat. He and his wife, Kathy, live in Brentwood with their two sons Patrick, 13, and Ryan, 11.

NATIONAL SOCIETY OF THE SONS OF THE AMERICAN REVOLUTION CENTER FOR ADVANCING AMERICA'S HERITAGE—LIBRARY AND NATIONAL HEADQUARTERS FULTON CONWAY BUILDING—805 WEST MAIN STREET, LOUISVILLE, KENTUCKY

In a statement issued by President General Bruce A. Wilcox and prepared by A. L. Post, Inc. (*inspection consultants*), he states, having inspected the two proposed buildings as possible candidates for conversion to the proposed National Headquarters for the Sons of the American Revolution (SAR), we have prepared a summary of the advantages presented by the Fulton Conway Building (FCB) that make it a more favorable choice over the Kentucky Opera Building (KOB) as follows:

Purchase Price The asking price for the FCB is \$1,900,000.00. That is approximately \$600,000.00 less than the asking price for the KOB.

Exterior Restoration Cost The FCB is two stories above grade with a cast iron façade. Although this façade is in need of restoration, the cost of the exterior restoration work will be considerably less than the exterior restoration work required for the KY Opera Building which is five stories and needs complete tuck pointing of the brick veneer.

Interior Improvement Costs The KOB is a functioning office building. However, it is separated for three separate tenants, not one, as will be the case for SAR. In addition, many of the improvements that exist in the KOB are either approaching the end of their service life or do not fit the design and construction program that is intended for SAR. As a result, SAR will incur an additional cost to demolish and remove these improvements during renovation work. Such improvements include HVAC systems, partitions, ceilings, and lighting.

Location Although both buildings are in close proximity, the FCB provides access to river views that will be a selling point for functions that will take place in this building for SAR and outside organizations.

Building Configuration At only two stories, the FCB allows for the museum and library to be located on one level with administrative offices above.



This configuration is much more desirable for efficiency than being spread out over five floors as would be the case in the KOB.

Accessibility As with the previous item, the two stories that are above grade provide greater accessibility within the FCB. Only one elevator will be required as opposed to the two that would be desirable in the KOB. In the event that someone does not want to wait for an elevator, they are more likely to make use of the stairs that go to just one other level. Being on the first floor will make the library and museum more desirable places to visit.


Building Structure The FCB was constructed with an unusually rigid foundation that will require little or no reinforcing to withstand the loading conditions generated by a museum and library. The KOB will require significant structural reinforcement to locate exhibits and book displays on upper levels.

Existing Improvements The FCB is an open shell that will allow for creative design in configuring various SAR functions without being tied down to the present structure of the KOB.

Roof Garden The roof garden that is proposed for the FCB is not possible in the KOB because of existing building configuration.

Façade The FCB comes with 100 feet of street frontage, more than double that that of the KOB. This expansive frontage allows for the creation of a grand façade that is suitable for a museum and a national headquarters.

Unique In general, the basic architecture of the FCB will allow for a unique design with interesting elements that will result in a unique facility. The KOB will place a unique facility into a typical five story office building.

HOUSE BILL 2460 By Watson

AN ACT to amend Tennessee Code Annotated, Title 15, Chapter 2, Part 1, relative to designating April 19 as "Patriots' Day." BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Title 15, Chapter 2, Part 1, is amended by adding the following language as a new, appropriately designated section: Section §15-2-114.

April 19 of each year shall be observed as "Patriots' Day," to be proclaimed as such by the governor, to honor and recognize the opening events of the War of the Revolution and the struggle through which the nation passed in its early days. Such day

shall not be a legal holiday as defined in § 15-1-101.

SECTION 2. This act shall take effect July 1, 2008, the public welfare requiring it.

Representative Eric Watson (R-Cleveland) filed this House Bill on the opening day of the 2008 Session, January 8, 2008. After successfully passing resolutions for three years, Patriot's Day is now eligible to be made a permanent holiday, recognized in Tennessee. If you see your State Representative or State Senator—remind them that this would be a nice tribute to our Revolutionary ancestors.

An incentive plan designed to reward Chapters for helping to secure presales for the 1,000 license plates required by the Tennessee Department of Safety to obtain approval has been developed and approved the TNSSAR Board of Governors. Specifically, the proposal to establish the TNSSAR License Plate

to support the John Sevier Endowment Fund is as follows:

PURPOSE: The Tennessee General Assembly has authorized the establishment of a TNSSAR License Plate, illustrated above. Proceeds from the sale of these personalized plates will support the TNSSAR John Sevier Endowment Fund.

SALES PLAN: The Tennessee Department of Safety requires that one thousand (1,000) license plates must be pre-sold before the license plates will be manufactured. We propose that each Chapter accept a quota for sales. Based upon approximately 800 members as of December 31, 2007, to sell 1,000 license plates, each member in TNSSAR would need to sell 1.20 license plates.

COST: A subscription form and a check in the amount of \$35.00 should be collected from each individual who reserves a TNSSAR license plate.

CHAPTERS TO BE REWARDED: Of the initial fee, \$25.00 is rebated to TNSSAR from the sale of each license plate (\$10.00 is a one time set-up fee). Of these funds, we propose that a \$5.00 commission will be distributed to each Chapter based upon each Chapter's sales. If a chapter sells 20 plates – then the Chapter will earn \$100.00.

If a Chapter meets or exceeds its sales quota, then the Chapter will be rewarded with an additional \$2.50 bonus per license plate sale (first year only). If a Chapter has 16 members and sells 20 license plates to meet its quota, then the Chapter would receive \$150.00 (\$5.00 commission + \$2.50 bonus = \$7.50 x 20 = \$150.00). All residual funds will be allocated to the John Sevier Endowment Fund.

Thereafter, on an annual basis, we propose to distribute 80% of the total proceeds from license plate sales to the John Sevier Endowment Fund and 20% to be allocated among the Chapters based on December 31 membership totals.

Please do your part to make this a reality. The Sons of Confederate Veterans earns more than \$50,000 each year from the sales of their license plates. Please reserve your SAR license plate now so the TNSSAR can reap the benefit of endowment fund growth, and so the public can enjoy a license plate to express their patriotism every day.

• 2. Lineal Descent from a Patriot with Acceptable Service

MEMBERSHIP ELIGIBILITY: A male citizen of good repute in the community, is a lineal descendant of an ancestor who was, at all times, unfailing in loyalty to, and rendered active service in the cause of American Independence, in a military capacity, or Patriotic Service as a civilian supporting the military, or holding certain civil offices. Lineal bloodline from the Patriot is required and must be documented. Collateral lineage is not acceptable. Recommendation by two members in good standing is required. No person advocating the overthrow of the Government of the United States by use of force or violence, shall be eligible for membership in the Society.

GETTING STARTED: An interested person may obtain information about how to contact SAR from a friend who is a member of SAR, SAR, C.A.R., or SR, or from the SAR website, which is http://www.sar.org. A list of SAR Chapters in each State is listed on this website, and an applicant may contact an officer of a Chapter near his home. Each State has a member who is designated as the "New Member Helper". In most States, this is the State Registrar and he will direct an applicant to a Chapter where the applicant lives, or the nearest Chapter, and forward the inquiry to that Chapter. The Chapter will be responsible for assisting prospective members with the application process.

PREPARING AN APPLICATION: An applicant may obtain a "working copy" of the application form from the website or from the Chapter through which he will apply for membership. The Chapter Registrar will work with the applicant who will provide the data and proof documents. The Registrar will prepare the final application using SAR software, on a special watermarked paper. He will advise the applicant of the application fees, which include the first year dues. The Chapter Registrar will forward the application to the State Registrar for review and further processing at the National Level.

<u>WHAT IS NEXT?</u>: An applicant will be a member of the Chapter which is preparing his application. He should visit that Chapter at its meetings, be introduced as an applicant, and meet the members. Approval may take up to two (2) months to process, and he will then be presented as a new member, given his membership credentials, and given an opportunity to participate in Chapter activities.
